## **Conditions for eligibility:**

- 1. The applicant applying for a residential plot must be a citizen of India or an Overseas Citizen of India, and must have been,- (a) born in Goa on or before the 19th day of December, 1961, or, (b) born of a parent who resided in Goa on or before the 19th day of December, 1961, or, (c) born in Goa and a resident of Goa continuously for the last thirty years, or, (d) resident of Goa for the last thirty years, or, (e) born in Goa of parents who have been resident of Goa for the last thirty years, on the date of making application for the plot. Provided that where the applicant is an Overseas Citizen of India, he shall obtain clearance of competent regulatory authorities prior to making the application.
- 2. The **applicant applying for a residential plot** shall not own a residential/commercial tenement or a residential/commercial plot or shop or office allotted by the Board in his name or in the name of any other member of his family within a period of 30 years immediately prior to the date of application, anywhere in the State of Goa and an **affidavit** to this effect shall be produced in **Form-I**.
- 3. The applicant shall fill in only one **e-application in Form II**, either in his/her own name or in the name of any other member of his/her family and shall apply only in one category to which he/she may belong, namely, either as a member of the general category or in any of the reserved categories. Provided that reserved category may also apply against general category, if so desired. Provided further that he/she shall not be eligible for allotment of two plots, if successful in both the categories. In case, there are no applications from any particular reserved category, the quota earmarked for such category shall be added to the general category.
- 4. The applicant should have attained the age of eighteen years at the time of making an application.

5. For plots at Sr. No. 1, 2, 4, 5 and 6 above the reservation for person belonging to different categories shall be as under:—

- 6. A "local" means a person who is eligible to make application under sub-rule (1) of clause (A) to rule 6 and residing within the jurisdiction of Panchayat/ Municipality/Corporation of the City of Panaji, for atleast last 10 years or whose parents have been resident of such Panchayat/Municipality/ Corporation for the last 10 years on the date of making application for plot situated within the jurisdiction of such Panchayat/Municipality/ Corporation or the residents of neighbouring villages/towns immediately abutting or adjoining the boundary of the area of the Panchayat/Municipality/Corporation of the City of Panaji.
- 7. The applicants shall submit the <u>self attested copies of the documents</u> including proof of birth (of the applicant/parent, as the case may be), income certificate, caste certificate (if applicable), residence certificate (of the applicant/parent, as the case may be) issued by competent authority, PAN card, Aadhaar Card, original affidavit in FORM-I and bank details (for refund) to the <u>Goa Housing Board office at Porvorim on or before</u> <u>16/07/2021 for scrutiny</u>, failing which, the application shall be liable for rejection and 5% of the initial deposit shall be forfeited to the Board and the balance amount shall be refunded to the applicant without any interest.
- 8. If an applicant withdraws from the scheme after depositing the initial deposit, 5% of such deposit shall be forfeited to the Board and the balance amount shall be refunded to the applicant without any interest.
- 9. Date and time to participate in e-auction and procedure of e-auction will be intimated to the eligible applicants.
- 10. All eligible applicants shall compulsorily participate in the 'e auction trial run' conducted live. The schedule of the same shall be intimated.
- 11. There shall be at least two applicant bidders present for the auction proceedings for each plot, failing which, the bidding shall defer.

12. The Managing Director may postpone/cancel/defer the e-auction proceedings

of any particular plot/plots, as the case may be, at any time without assigning

any reasons thereof.

13. The decision of the Managing Director in the matter of allotment of plot by

e-auction to the highest bidder shall be final and binding on the bidders.

14. The allotment of plot shall be on "as is where is basis" and the allottee shall

not have any right to complain or raise any objection about nature, condition

or planning etc., or to claim any damage or compensation on any account

from the Board.

15. The allottee shall pay the full consideration of the residential plot allotted

within a period of 60 days from the date of receipt of the order of

allotment, failing which, the order shall stand cancelled without any further

notice and 5% of the initial deposit of the applicant shall be forfeited to the

Board and the balance amount shall be refunded to the applicant without any

interest.

16. The allotment of plots shall be in terms of the Goa Housing Board

(Registration, Allotment and Sale of Plots) Rules, 2016 and amendments

thereon. The said Rules are available on the Goa Housing Board website
