## **INSTRUCTIONS TO CONTRACTORS:**

The online application should accompany the following documents (Scan and Upload on the e-Tender website):

- a. Attested copy of valid Registration Certificate.
- b. Attested copy of valid PAN Card
- c. Attested copy of valid GST Certificate
- d. Mode of Payment towards the Tender Document Fee(TDF), Tender Processing Fee(TPF) & Earnest Money Deposit(EMD) to be paid online through e-payment mode via:
- i. National Electronic Fund Transfer(NEFT)/Real-Time Gross Settlement (RTGS)/Axis Bank Over-the-counter(OTC). Tenderer requires download pre-printed Challan towards credit of ITG available on e-tender website and make its payment through any of their Bank.
- ii. Internet Payment Gateway (Debit/Credit card of type VISA, MASTERCARD or RuPay.
- iii. Net Banking Payment can be made through the Internet Banking of Any Bank.

Note: Any Payments made through NEFT/RTGS/OTC will take 24 hours for its reconciliation. Hence the payments through NEFT/RTGS/OTC should be made

at least TWO BANK WORKING DAYS in advance before any due date

- e. The applicant should submit a declaration giving the names of the works in hand in the above mentioned category on stamp paper of Rs 50/-
  - 1. The intending bidder must read the terms and conditions of CPWD carefully. He should only submit his bid if he considers himselfeligibleand he is in possession of all the documents required.
  - 2. The Bidder should produce a valid attested copy of the electrical license for upto 11 KV (valid for carrying out work upto 11 KV) from the Licensing Board, Government of Goa.
  - 3. Information and instructions for the tenderer posted on website shall form part of the bid document.
  - 4. The bidder should inspect the site before quoting.
  - 5. For power clearance /shutdowns which may be required for carrying out the work for this contract, necessary permissions should be obtained by making a written application from the concerned Asst. Engineer, Elect., Porvorim or his representative.
  - 6. The Contractor shall be governed by the agreement under PWD form 7.
  - 7. It is the responsibility of the tenderer to ensure the credit of tender document fees, tender processing fees and EMD into respective receiving bank accounts of ITC via various modes of payments mentioned above, on or before the last due date and time of the tender.
  - 8. The excel sheet uploaded is just for reference purpose only. No bid would be accepted via excel sheet. All quoting should be done via forms provided in the system itself.

- 9. The tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The department shall not be responsible for non-accessibility of e-tender portal due to internet connectivity issues and technical glitches at the tenderers end.
- 10. The tenderer shall be responsible for the correctness and genuineness of the documents uploaded during the tender submission. Any discrepancies in the matter will be liable for rejection and suitable action.
- 11. No hard copies of the documents should be submitted in the tender box. However, the lowest tenderer shall submit the hard copies of the documents scanned and uploaded and original copy of declaration on stamp paper after opening of the tender.
- 12. Any item which is not specified in quotation and if same is required for the work of erection should be treated as included in the quotation and should be supplied to a party without any additional cost.
- 13. All the certificates of supply of materials should be submitted to this office.
- 14. Information and Instructions for bidders posted on website shall form part of bid documents.
- 15. The bid document consisting of plans, specifications, the schedule of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <a href="https://eprocure.goa.gov.in/">https://eprocure.goa.gov.in/</a>
- 16. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website. - 17. The intending bidder must have/obtain a valid class III digital signature with signing and encryption to submit the bid.
- 18. At the time of opening, the scanned copies of the Documents uploaded at the time of submission of tender will be verified with the physical/hardcopies submitted and bids of only those contractors whose physical copy matches with the uploaded copies will be accepted for opening.

Incomplete applications shall be summarily rejected and right to reject any or all the tenders including the lowest without assigning any reason thereof is reserved.
