The Executive Engineer, Goa Housing Board, Porvorim Goa, invites Percentage Rate E-Tenders on online mode only, from the valid approved eligible electrical contractors registered in appropriate Class and Categories possessing experience in similar works in respect of the tender for the following work:-

The online application should accompany the following documents (Scan and upload on the e-Tender website):

- a. Attested copy of valid Registration Certificate.
- b. Attested copy of PAN Card
- c. Attested copy of valid GST registration Certificate.
- d. Mode of Payment towards Tender Document Fee (TDF), Tender Processing Fee (TPF) & Earnest Money Deposit (EMD) to be paid online through e-payment mode via:
 - i) National Electronic Fund Transfer (NEFT) / Real-Time Gross Settlement (RTGS) / Axis Bank Over-The-Counter (OTC). Tenderer requires to download pre-printed challan towards credit of ITG available on e-tender website and make its payment through any of their Bank.
 - ii) Internet Payment Gateway (Debit / Credit Card of type VISA, MasterCard or RTGS).
 - iii) Net Banking: Payment can be made through the internet banking of any bank.

Note: Any payments made through NEFT / RTGS / OTC will take 24 hours for its reconciliation. Hence the payments through NEFT / RTGS / OTC should be made at least TWO BANKING WORKING DAYS in advance before any due date and upload the scanned copy of challans in the e-tender website as a token of payment.

e. The applicant should submit a declaration giving the names of the works in hand in the above mentioned category on stamp paper of Rs. 100/-

INSTRUCTIONS TO CONTRACTORS

- 1. The intending bidder must read the terms and conditions of CPWD -6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 2. The Bidder should produce a valid attested copy of the electrical licence for 11 KV level & above (valid for carrying out work 11 KV & above) from the Licensing Board, Government of Goa.
- 3. The bidder should inspect the site before quoting.
- 4. For power clearance /shutdowns which may be required for carrying out the work for this contract, necessary permissions should be obtained by making a written application from the concerned Asst. Engineer, Elect. or his representative.
- 5. The Contractor shall be governed by the Goa Housing Board agreement under Form 7.
- 6. Any item which is not specified in quotation and if same is required for the work of erection should be treated as included in the quotation and should be supplied to a party without any additional cost.
- 7. All the certificates of supply of materials should be submitted to this office.
- 8. Information and Instructions for bidders posted on website shall form part of bid documents.
- 9. The bid document consisting of specification, the schedule of quantity of various types of items to be executed can be seen and downloaded from website https://eprocure.goa.gov.in.
- 10. Those bidders not registered on the website mentioned above, are required to get registered beforehand.
- 11. The intending bidder must have/obtain a valid digital signature to submit the bid.
- 12. On opening date, the contractor can login and see the bid opening process.
- 13. Bidder must ensure to quote rate of each item. The column meant for quoting rate in figures appears in sky blue colour (Rupees in words will be automatically taken).
- 14. THE CONTRACTOR SHALL QUOTE EXCLUDING GST AND GST AS APPLICABLE SHALL BE PAID EXTRA ON TOTAL COST OF THE WORK DONE.
- 15. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO) & will be treated as incomplete. Also name of the bidder should be entered in respective cell.
- 16. It is the responsibility of tenderer to ensure the credit of tender document fees, tender processing fees and EMD in to respective receiving bank accounts of ITC via various modes of payments mentioned above, on or before due date and time of tender.
- 17. The excel sheet uploaded id just for reference purpose only. No bid would be accepted via excel sheet. All the quoting would be done via forms provided in the system itself.
- 18. The tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time of receipt of tenders. The department shall not be responsible for non accessibility of e-tender portal due to internet connectivity issues and technical glitches at the tenderers end.
- 19. The tenderer shall be responsible for the corrections and genuiness of the documents uploaded during the tender submission. Any discrepancies in the matter will be liable for rejection and suitable action.
- 20. No hardcopies of the documents to be submitted in the tender box. Only the successful/lowest bidder should submit the hard copies of uploaded documents within week's time from the date of online opening.
 - Incomplete applications shall be summarily rejected and right to reject any or all the tenders including the lowest without assigning any reason thereof is reserved.
