The Executive Engineer, Goa Housing Board, invites Percentage Rate E-Tenders on online mode only, from the valid approved eligible Contractors/Specialized agency for erection of Sewage Treatment Plant in the Government/Semi Government/Private organizations registered in the state of Goa possessing experience in similar works in respect of the tender for the following work:-

The date and time of opening of online tender is 05/03/2024 after 3:30 PM in the office of the Executive Engineer, Goa Housing Board, New Market Complex, Porvorim, Bardez-Goa

The online application should accompany the following documents (Scan and upload on the e-Tender website):

- a. Attested copy of valid Registration Certificate.
- b. Attested copy of PAN Card
- c. Attested copy of GST valid registration Certificate.
- d. Mode of Payment towards Tender Document Fee (TDF), Tender Processing Fee (TPF) & Earnest Money Deposit (EMD) to be paid online through e-payment mode via:

- i) National Electronic Fund Transfer (NEFT) / Real-Time Gross Settlement (RTGS) / Axis Bank Over-The-Counter (OTC). Tenderer requires to download pre-printed challan towards credit of ITG available on e-tender website and make its payment through any of their Bank.
- ii) Internet Payment Gateway (Debit / Credit Card of type VISA, MasterCard or RuPay).
- iii) Net Banking: Payment can be made through the internet banking of any bank.

Note: Any payments made through NEFT / RTGS / OTC will take 24 hours for its reconciliation. Hence the payments through NEFT / RTGS / OTC should be made at least TWO BANKING WORKING DAYS in advance before any due date and upload the scanned copy of challans in the e-tender website as a token of payment.

- e. The applicant should submit a declaration giving the names of the works in hand in the above mentioned category on stamp paper of Rs. 100/-
- f. THE CONTRACTOR SHALL QUOTE THE RATES EXCLUDING GST AND GST AS APPLICABLE SHALL BE PAID EXTRA ON TOTAL COST OF THE WORK DONE.

INSTRUCTIONS TO CONTRACTORS

- 1. The intending bidder must read the terms and conditions of CPWD -6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 2. The bidder should inspect the site before quoting.
- 3. The Contractor shall be governed by the agreement under PWD form 7.
- 4. Any item which is not specified in quotation and if same is required for the work of erection should be treated as included in the quotation and should be supplied to a party without any additional cost.
- 5. All the certificates of supply of materials should be submitted to this office.
- 6. Information and Instructions for bidders posted on website shall form part of bid documents.
- 7. The bid document consisting of plans, specifications, the schedule of quantity of various types of items to be executed and the set of terms and condition of the contract to be complied with and other necessary documents can be seen and downloaded from website https://eprocure.goa.gov.in.
- 8. The intending tenderer must have successfully completed at least three (3nos) of Sewage Treatment Plants(STP) of 100% of equivalent or more capacity and must have supplied, installed and commissioned at least one number of equivalent or higher capacity plant based on Membrane Bio Reactor (MBR) technology. Tenderer should submit a declaration giving the names of above works on stamp paper of Rs. 100/-. Copies of Purchase/work Orders and Completion Certificates duly self attested should be submitted along with the bid.
- 9. It shall be the responsibility of the contractor to prepare all required civil construction drawings and the same shall be submitted to the Goa Housing Board for approvals before start of construction.
- 10. The necessary power and water supply required for the work to be arranged by the contractor.
- 11. The contractor shall furnish manual for operation and maintenance of STP and log book for operation of plant.
- 12. P and I diagram of equipment of layout in A3 and A1 size with lamination.
- 13. Any variation in drawings arising due to site condition will be in the scope of contractor.
- 14. "AS BUILT" layout/drawing of equipment layout in A2 and A1 size with lamination.
- 15. During commissioning all consumable shall be in contractor's scope for a week.
- 16. First water sample test report is in contractor's scope.
- 17. Only documentation and coordination for getting approval from GPCB is in contractor's scope and charges in Housing Boards scope.
- 18. On opening date, the contractor can login and see the competitor bid sheets.

- 19. Those bidders not registered on the website mentioned above, are required to get registered beforehand.
- 20. The intending bidder must have/obtain a valid digital signature to submit the bid.
- 21. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 22. It is the responsibility of tenderer to ensure the credit of tender document fees, tender processing fees and EMD into respective receiving bank accounts of ITC via various modes of payments mentioned above, on or before last due date and time of tender.
- 23. The excel sheet uploaded id just for reference purpose only. No bid would be accepted via excel sheet. All the quoting should be done via forms provided in the system itself.
- 24. The tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The department shall not be responsible for non-accessibility of e-tender portal due to internet connectivity issues and technical glitches at the tenderers end.
- 25. The tenderer shall be responsible for the correctness and genuineness of the documents uploaded during the tender submission. Any discrepancies in the matter will be liable for rejection and suitable action.
- 26. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO) & will be treated as incomplete. Also name of the bidder should be entered in respective cell.
- 27. No hard copies of the documents to be submitted in the tender box. Only the successful/lowest bidder should submit the hard copies of the documents scanned and uploaded within week's time from the date of online opening.

Incomplete applications shall be summarily rejected and right to reject any or all the tenders Including the lowest without assigning any reason thereof is reserved.
